


Context Statement

Felixstow Primary School caters for students from R-6. At the time of this report, the enrolment in 2023 is 79. Felixstow Primary School is classified as Category 5 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 5% Aboriginal students, 10% students with disabilities, 23% students with English as an additional language or dialect (EALD) funded background, 3% children/young people in care. Performance Summary NAPLAN Proficiency

In 2023, the Australian Curriculum, Assessment and Reporting Authority (ACARA) - a Commonwealth Independent statutory authority - announced changes to NAPLAN performance reporting. This new way of reporting by ACARA that NAPLAN results from 2023 will not be comparable to previous years. The new approach replaces the previous numerical NAPLAN bands and the national minimum standard.









Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or nongovernment school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.

I'd like to thank my fellow governing council members for 2023.

Regular staff representatives are Skye van Heusden and Gillian Hodges, with regular attendances of individual class teachers for learning updates. Governing Council Members have appreciated the input of varied staff to learn about what is happening across classrooms.

The Annual School Budget was debated, including no change to service and materials fees for parents and was approved in consultation with school families.

We approved pupil free days for 2023.

The Governing Council, along with Skye have continued working with the NPSP council on improving the road safety strategies on Briar Rd. We have received preliminary plans for a dedicated school crossing

and the addition of a speed advisory sign has been welcome for the start of this school year.
